

## The on!® HOLE-IN-WON Sweepstakes

### Official Rules

**1. Employees, officers, and directors of Helix Innovations LLC (the “**Presenter**”), or any of Presenter’s respective parents, affiliates, subsidiaries, representatives, consultants, contractors, legal counsel, advertising, public relations, promotional, fulfillment, and marketing agencies including Merkle Inc. Administrator’s computer is the official timekeeping device for the Promotion.

**4. How to Enter:** To enter the Promotion, you must first become a registered user at [www.onnicotine.com](http://www.onnicotine.com). If you are not a registered user, go to [www.onnicotine.com](http://www.onnicotine.com) and follow the instructions to register for free. When you register, you will be assigned a unique 8 to 12-digit customer number (“**CCN**”) and will select, or may be assigned, a user ID that will be associated with your account. By registering at [www.onnicotine.com](http://www.onnicotine.com), you agree to be added to the on!® email mailing list. You may unsubscribe from marketing emails by following the link to “Unsubscribe”

contained within any received marketing email at any time without impacting your Sweepstakes entry or Instant Win play.

Then, during the Promotion Period, log on to [www.onnicotine.com](http://www.onnicotine.com) using your registered user account and navigate to the on!® HOLE-IN-WON Sweepstakes tile. Follow the links and instructions to enter the Promotion and agree to these Official Rules. Upon following and successfully completing the on-screen instructions, you will automatically receive one (1) Instant Win play and one (1) entry into the Sweepstakes. The Instant Win results will be instantly displayed; however, potential winners may be subject to verification and validation prior to receiving a prize. Potential winners of Instant Win prizes will be provided directions for validation.

arbitration panel or other tribunal of competent jurisdiction, then (a) the validity, legality and enforceability of such provision as applied to any other particular facts or circumstances, and the other provisions of these Official Rules, shall not in any way be affected or impaired thereby; and (b) such provision shall be enforced to the maximum extent possible. In addition, if any provision contained in these Official Rules shall for any reason be held to be excessively broad as to duration, geographical scope, activity or subject, it shall be construed by limiting and reducing it, so as to be enforceable to the extent compatible with applicable law.
